## Eco-design of our products

We are committed to:

- **Increasing reliability and service life:** Marketed worldwide, the transportation of our products generates air pollution. We are working to offer highly reliable products and to avoid transportation as much as possible.
- **Reducing energy consumption:** Our products, and in particular our transmitters, are in operation 24 hours a day, 7 days a week for an average operating life of 8 years. Reducing their power consumption reduces the impact of our activity in the long term and also allows our customers to reduce their environmental impact.
- **Reducing the number of electronic components,**
- **Choosing components and materials for greater recyclability.**

## Internal operations

- We seek to **reduce our waste on a daily basis**, by eliminating single-use products and reducing our consumables:
  - We have eliminated plastic cups from coffee machines, eliminated water fountains and distributed reusable water bottles to employees.
  - Our printers and photocopiers are set up by default to guarantee black and white and automatic double-sided printing.
- We are committed to **recycling our waste**, which must be sorted and assigned to the right recycling channel:
  - We have signed a partnership with external service providers for the recovery of all waste related to our activity and our operation: electrical and electronic, batteries and accumulators, packaging, metal, wood ...
- Our premises are designed with the environment in mind:
  - Low energy consumption plant, designed to optimize thermal behavior and with recovery of natural resources and energy,
  - Offices equipped with circadian lighting tiles that generate an average of 60% energy savings.
- We **favor local partners** for our main suppliers and subcontractors in order to reduce transportation.
- We ask for a strong commitment from our employees. All our employees sign our **Environmental Charter** which encourages them to:
  - Carry out selective sorting,
  - Reduce their consumption of disposable products,
  - Not to waste water and energy,
  - Be actively involved by sharing their ideas.

## Ecosystem

- We **support the association Arbres et Paysages en Gironde** to continue to maintain 40,000 trees planted at our initiative.
- We participate in awareness-raising actions for employees and local companies in the Nouvelle-Aquitaine region.
